

1. GENERAL PROVISIONS

1.1. UAB "Delfi" ensures that users have the opportunity to review the terms of service before purchasing a ticket, as provided on the websites of conferences organized by "Delfi".

1.2. Before purchasing a ticket/tickets, the buyer must familiarize themselves with and adhere to these rules. By purchasing a ticket/tickets, the buyer is considered to have read and agreed to these rules.

2. TICKET RESERVATION AND PURCHASE PROCEDURE

2.1. Tickets for conferences organized by UAB "Delfi" can be purchased remotely via the ticket distribution platform "Fienta" or directly through UAB "Delfi." To purchase an e-ticket, the buyer must complete a registration form. Registration ensures secure delivery of the e-ticket, payment confirmation, and safe identification of the buyer. The submission of buyer data and account management are carried out in accordance with the Service Provider's Privacy Policy.

2.2. Groups wishing to purchase multiple tickets can place orders:

Orders are confirmed and tickets are sent only after payment.

2.3. If the buyer purchases tickets through the "Fienta" ticket distribution platform and wishes to receive a VAT invoice, they can request it during the ticket order process or receive a proforma invoice.

2.4. The event is accessible for individuals with mobility disabilities. Those with a valid disability certificate can contact the ticket sales department:

A special ticket price of €69 (including VAT) applies.

2.5. A person accompanying an attendee with mobility disabilities must purchase a separate ticket.

2.6. One accompanying person per disabled attendee is eligible for a special ticket price of €69 + VAT. Other accompanying persons must purchase tickets at the officially announced price.

2.7. The event will be recorded and photographed. By purchasing a ticket, you agree that your image may be captured in video or photo materials used for journalistic content or marketing purposes by conference organizers and their partners.

3. TICKET USAGE RULES

3.1. A single electronic ticket can only be used by one person. During the LOGIN conference, it is exchanged for a wristband. The electronic ticket holder must not allow others to copy their ticket or transfer the wristband.

3.2. Tickets are personalized. Only the person whose name appears on the ticket and who has the wristband can enter the event.

3.3. Copying, reproducing, forging, reselling, or acquiring tickets by any unlawful means is strictly prohibited.
